

We are registered with the U.S. Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services fees differ and it is important for you to understand the differences. What investment services and advice can you provide me?

Our firm offers investment advisory services, which are fully described in our Form ADV Part 2A (“Disclosure Brochure”). Our services include financial planning, consulting and investment management services to individuals, foundations, defined contribution (401k) and defined benefit retirement plans. As part of our standard services, we monitor investments that we manage on a continuous and ongoing basis. Financial planning and investment consulting recommendations are not actively monitored. There are no material limitations to our monitoring. We accept discretionary and/or non-discretionary authority to implement the recommended transactions in client accounts. The level of discretion is determined in our agreement and there are no material limitations on the authority. For non-discretionary services, you make the ultimate decision regarding the purchase or sale of investments. We do not offer advice on proprietary products. We offer advice on exchange-traded funds (“ETFs”), mutual funds and, to a lesser extent, exchange-traded notes (“ETNs”), individual debt and equity securities and options, as well as the security components of variable annuities and variable life insurance contracts in accordance with the investment objectives of the client. Our services are subject to a \$300,000 minimum account value.

What fees will I pay?

We offer our services on a fee basis. We charge a fee based upon assets under management for investment management and wealth management services. If you elected to engage us in financial planning services without investment management services, then those services would be subject to an hourly or fixed fee, otherwise they are included in the wealth management fee. For ongoing services, the annual fee is prorated and charged quarterly in arrears.

In addition to the advisory fees paid to us, you also incur certain charges imposed by third parties, such as broker-dealers, custodians, etc. These additional charges include custodial fees, charges imposed directly by a mutual fund or ETF in your account, which is disclosed in the fund’s prospectus (e.g., fund management fees and other fund expenses), deferred sales charges, odd-lot differentials, transfer taxes, wire transfer and electronic fund fees, and other fees and taxes on brokerage accounts and securities transactions.

The more assets there are in your advisory accounts, the more you will pay in fees, so the firm may therefore have an incentive to encourage you to increase the assets in your account or manage them in a way where the account value increases, leading to higher revenues for us. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the advice we provide you. Here are some examples to help you understand what this means.

- **Third-Party Payments:** While we do not receive compensation from third parties when we recommend investments, our supervised persons or affiliates can recommend insurance products in their individual capacities. This results in an incentive for our supervised persons or affiliates to recommend those products and potentially more frequent purchases.

How do your financial professionals make money?

Our financial professionals are compensated based on the following factors:

- Revenue the firm earns from the financial professional's advisory services or recommendations. This results in an incentive to take steps to maximize assets under management and revenue to the firm.
- The product sold and its sales commissions. While these are not earned as financial professionals of our firm, they result in an incentive to recommend certain insurance products.
